- d) extracts of the selected film may be broadcast on television and/or radio for promotional purposes only, and
- e) all VHS/DVD preview screeners in the possession of the Festival may be available during the Festival only at an exclusive viewing stand for participants.

DEADLINES

For selection purposes, the VHS/DVD preview screener must be received by 1 June 2008.

For selected films, the prints must be received by 1 October 2008.
